Upon the declarations of Chris Goff, dated November 19, 2010, Slade R. Metcalf, dated November 19, 2010 and Rachel F. Strom, and the exhibits annexed thereto, and good and sufficient cause appearing therefore, it is hereby

ORDERED, that Gawker Media LLC (“Gawker”) show cause before a motion term of this Court, at Room ^{26B}____, United States Courthouse, 500 Pearl Street, in the City, County and State of New York, on November ³⁰____, 2010 at ^{11:00}____ o’clock in the ~~fore~~ ^{fore} noon thereof, or as soon thereafter as counsel may be heard, why an order should not be issued pursuant to Rule 65 of the Federal Rules of Civil Procedure enjoining Gawker during the pendency of this action from continuing to distribute, publish or otherwise transmit pages from the book *America By Heart* by Sarah Palin (the “Book”); and it is further

ORDERED that, sufficient reason having been shown therefore, pending the hearing of plaintiff’s application for said preliminary injunction, pursuant to Rule 65, Fed. R. Civ. P., Gawker is temporarily restrained and enjoined from continuing to distribute, publish or otherwise transmit pages of the Book; and it is further

ORDERED that security in the amount of \$ 1000 be posted by HarperCollins prior to November ¹² , 2010, at 5:00 o'clock in the afternoon of the day; and it is further

ORDERED that papers in response to the motion, if any, shall be served upon Hogan Lovells US LLP at 875 Third Avenue, New York, New York 10022, Attention: Slade R. Metcalf, Esq. & Katherine M. Bolger, Esq., no later than noon o'clock M. on the 21st day of November, 2010 and reply papers, if any, shall be served by hand delivery on and filed prior to the hearing, ~~counsel appearing for Gawker no later than o'clock M. on the day of , 2010;~~ and it is further

ORDERED that service of a copy of this order together with the underlying papers upon which it was granted, on Gawker shall be good and sufficient if made by hand delivery or prepaid overnight courier to Gawker's principal business address on or before 5:00 o'clock in the after noon on the 22nd day of November, 2010, shall be deemed good and sufficient service thereof.
